## 158 - Anti-Corruption Commission

### **Allocations and Activities**

#### 1 Main functions of the Anti-Corruption Commission:

- a. To inquire into and conduct investigation under section 17 Anti-Corruption Commission Act, 2004, of the offences set out in the schedule of Anti-corruption Commission Act, 2004, Anti-Corruption Commission (Amendment) Act, 2013 and Anti-Corruption Commission (Amendment) Act, 2016;
- b. To file and conduct cases under this Act on the basis of inquiry and investigation conducted under clause
- c. To hold inquiry into any allegation of corruption on its own motion, or on an application made by an aggrieved person or any person on his/her behalf;
- d. To review the measures under any other laws for prevention of corruption and to submit recommendations to the Hon'ble President for effective implementation thereof:
- e. To formulate research scheme for prevention of corruption and to submit recommendations to the Hon'ble President for taking actions on the basis of such research findings;
- f. To create sense of honesty and integrity in order to prevent corruption and to take measures to raise public awareness against corruption
- 9. To identify various sources of corruption existing in Bangladesh in the context of socio-economic conditions and to submit recommendation to the President for taking necessary steps;
- h. To perform any duty assigned to the Commission under anti-corruption laws; and
- i. To perform such other functions as may be necessary for prevention of corruption.

#### 3 In FY 2024-25, the following important activities/projects/programmes are scheduled to be implemented;

- a. Reconstituting the "District corruption Prevention Committee" consisting of 13 members and "Upazila Corruption Prevention Committee" consisting of 9 members in all districts, upazilas and unions respectively to institutionalize social movement against corruption throughout the country;
- b. Taking initiative to establish "Satata-Shangha" as an associate body of the Corruption Prevention Committee in their respective area's educational institutions, like schools, colleges, madrasas, universities, dormitories, training institutions etc in order to involve the youth in the programmes of public awareness building against corruption;
- c. Launching "Integrity Store" (Satata Store), a seller free store in the educational institutions in order to motivate the students to practice integrity:
- d. Arranging Public Hearing; and
- e. Construction of new Building for ACC's Khulna, Rangpur, Rajshahi, Barishal and Sylhet Divisional Offices and vertical extension of Mymensingh Divisional Office.
