158 - Anti-Corruption Commission

Allocations and Activities

1 **The main functions of the Anti-Corruption Commission are:**

- a. To inquire into and conduct investigation under section 17 of Anti-Corruption Commission Act, 2004, of the offences set out in the schedule of Anti-Corruption Commission Act, 2004, Anti-Corruption Commission (Amendment) Act, 2013 and Anti-Corruption Commission (Amendment) Act, 2016;
- b. To file and conduct cases under this Act on the basis of inquiry and investigation conducted under clause (a);
- c. To hold inquiry into any allegation of corruption on its own motion, or on an application made by an aggrieved person or any person on his/her behalf;
- d. To review the measures where are recognized by any law for preventing corruption and submit recommendations to the President for the effective implementation thereof;
- e. To make research scheme for prevention of corruption and submit recommendations to the President for taking action on the basis of such research findings;
- f. To create feeling of honesty and integrity in order to prevent corruption and to take measures to raise public awareness against corruption;
- g. To identify various sources of corruption existing in Bangladesh in the context of socio-economic conditions and submit recommendations to the President for taking necessary steps;
- h. To perform any duty assigned to the Commission regarding anti-corruption related law; and
- i. To perform such other functions as may be necessary for prevention of corruption.

- b. Taking initiative to establish "Satata-Shangha" as an associate body of the Corruption Prevention Committee in their respective area's educational institutions, like schools, colleges, madrasas, universities, dormitories, training institutions etc in order to involve the youth in the programmes of public awareness building against corruption;
- c. Implementation the construction of the office building for 06 Divisional offices; and
- d. Implementation the project titled "Strengthening the Capacity of Anti-Corruption Commission".
