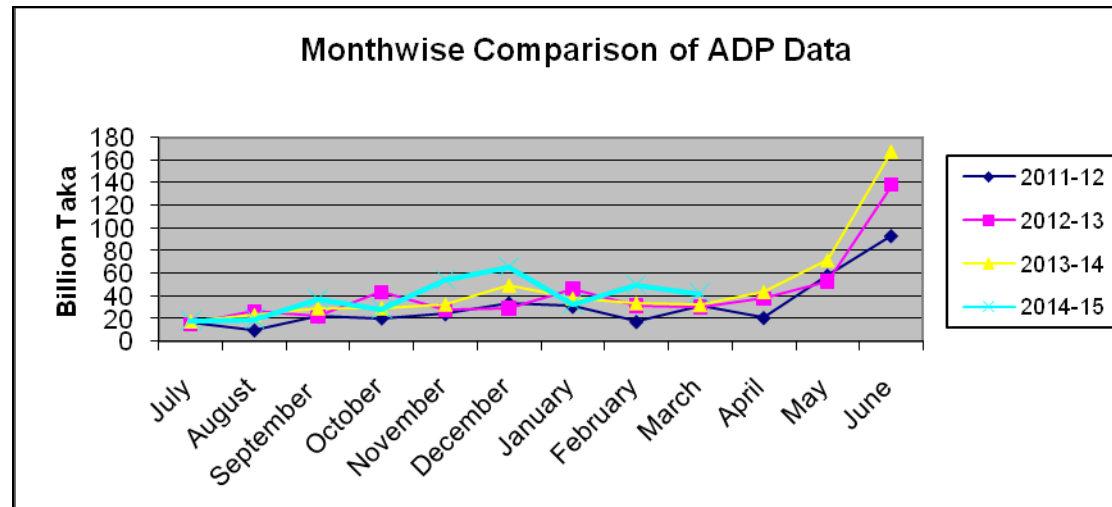

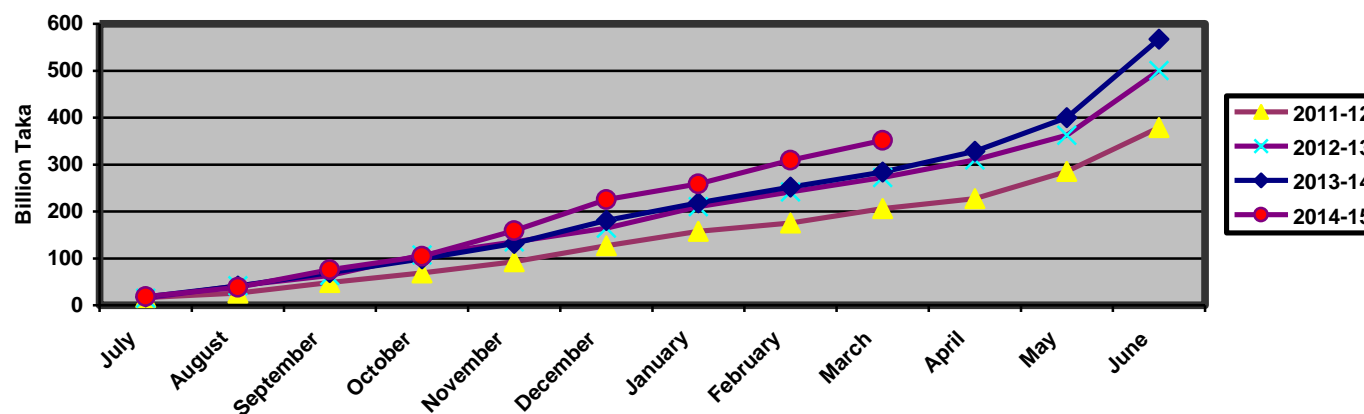

#### Cumulative ADP Expenditure



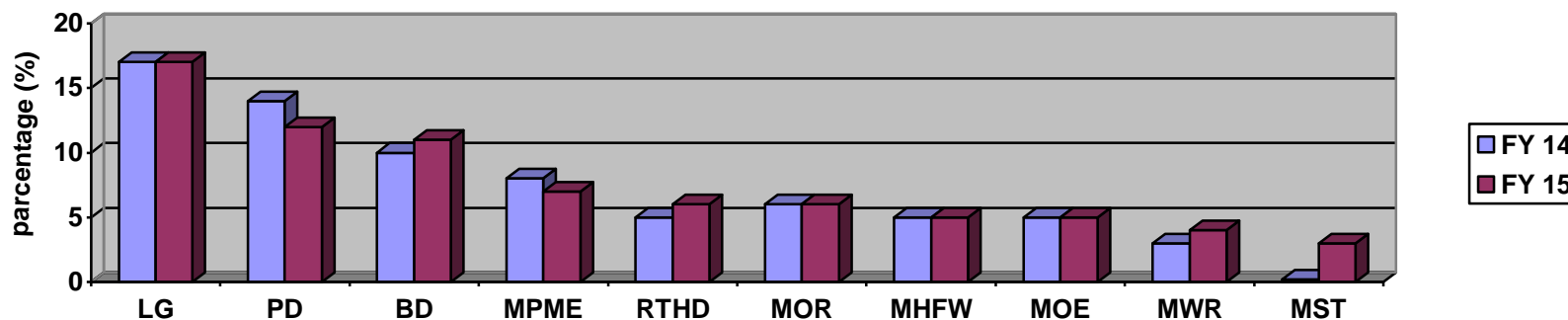
