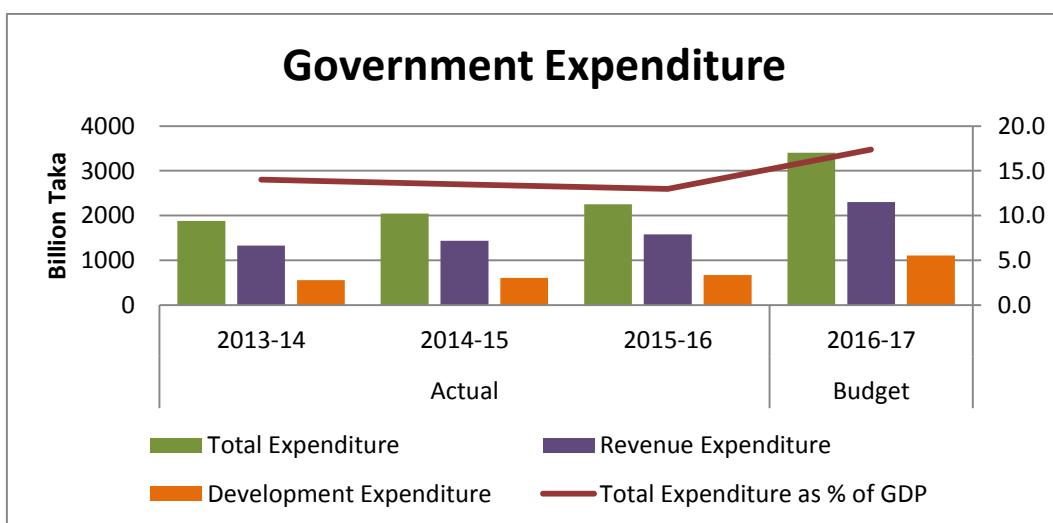

## *Executive Summary*

**Fiscal Report is prepared on monthly basis.** It basically contains information on government expenditure, revenue and overall balance. The report is prepared from data generated from the Integrated Budget & Accounting System (iBAS) of the Finance Division, Ministry of Finance. In this report, fiscal year (FY) refers to the period from September 01 to June 30 of the next year. Taka is Local Currency Unit (LCU), and one crore is ten million.

**Government expenditure** is shown under two broad categories, namely, Non-Development Expenditure and Development Expenditure. Total actual non-development spending up to September, 2016 in the current fiscal year (FY17) is 14.8 percent of the non-development budget estimates. Actual development expenditure during the same period is 6.7 percent of the development budget estimate. Note that, three memorandum items (Net Outlay of Food Accounts Operation, Loans and Advances and Non ADP Employment Generation Programme) are out of these two broad categories.

**Revenue income** is generated from tax and non-tax sources. Up to September 2016, 18.0 percent of total revenue target has been achieved. During this period, major share of the revenue came from NBR (National Board of Revenue) taxes (80.8 percent). Total NBR tax collection is 17.4 percent of the annual target. Regarding NTR (Non Tax Revenue) 21.8 percent of the annual target has been achieved.

**Balance (Surplus/Deficit)** Overall balance of the budget is calculated either by including grants or by excluding grants. Up to September 2016, in current fiscal, overall balance (excluding grants) is 0.04 percent of the estimated GDP.

## 1.0 NON-DEVELOPMENT EXPENDITURE

### 1.1 NON-DEVELOPMENT EXPENDITURE: GENERAL CLASSIFICATION

#### 1.1.1 SECTOR WISE ALLOCATION & GROWTH

ALLOCATIONS FOR NON-DEVELOPMENT EXPENDITURE AGAINST DIFFERENT MINISTRIES/DIVISIONS ARE GROUPED INTO 14 SECTORS. SECTOR-WISE UTILIZATION PATTERN ALONG WITH PROGRESS SO FAR MADE HAS BEEN PRESENTED IN TABLE 1.

Some of the noteworthy features are:

- For FY17, budget allocation was raised by 31.5 percent over the FY16 revised estimates and 16.7 percent over the original budget
- Up to September 2016, spending in Fuel and Energy, Education, Public Order and Safety, Health, Industries, Jute, Textiles, Commerce, Labor & Overseas, Interest payment, Recreation, Culture and Religious Affairs, Defense and Transport and Communication sectors were on the higher side. Below-average utilization in some sectors, like General Public Services, Social Security and Welfare, Agriculture sectors contributed to a less-than-expected performance in total non-development spending
- As a whole, non-development spending up to September 2016 amounts to 14.8 percent of the non-development budget.

### 1.1.2 Broad Sector wise Allocation

Allocations for non-development expenditure against different ministries/divisions are also classified under six broad categories, namely, administration, social infrastructure, physical infrastructure, agriculture, interest payment and others. The following table contains broad sector-wise information:



- Broadly in the budget for FY17, share of administrative expenditure has increased, whereas allocations against all other categories are reduced in comparison to the actual expenditure of FY16
- Till September 2016, among all categories share of Social Infrastructure expenditure was the highest

### 1.1.3 Sector Share in Resource Utilization

(Up to September)




Total non-development spending up to September, 2016 in the current fiscal year is 14.8 percent of the budget estimates. Sector-wise share in utilizing resources under non-development expenditure is shown in Figure 1.

- Individually the largest share goes to Education (24.9 percent) Interest Payment (23.6 percent) followed by, Public Order and Safety (11.9 percent), and defense (11.6 percent).

#### 1.1.4 Sector wise Utilization

Sector-wise utilization pattern of non-development spending up to September, 2016 is shown in **Figure 2**. This figure exhibits the comparative position of different sectors in terms of utilization of allocated resources. In terms of utilization, broadly fuel and energy, and education sectors have shown better performance. A table containing detailed data is annexed as **Appendix 1**.

#### 1.1.5 Ministry-wise Utilization


For current 2016-17 fiscal year, actual spending (non-development) up to September, 2016 is 14.8 percent of the budget estimate, which is 13.9 percent higher compared with the same period of the previous fiscal year. Ministry-wise utilization pattern of the non-development spending is presented in **Appendix 2**.

### 1.2 Non-Development Expenditure: Economic Classification


Besides broad sector-wise and ministry-wise classification, non-development spending is also categorized into 08 economic groups, namely, Pay and Allowances (**PA**), Goods & Services (**GS**), Interest Payment (**IP**) [Domestic & Foreign], Subsidies & Current Transfer (**SCT**), Block Allocation (**BA**), Acquisition of Assets and Works (**AAW**), Investment in share & equities (**ISE**), Programme financed from Non-Development Budget (**PFNDB**). Status of actual spending up to September 2016 as per economic classification is shown in **figure 3** and **4**. Detailed structure & pattern of Non-development expenditure under this classification is included in the Appendix (**Appendix 3**).

- Up to September 2016, utilization rate of total non-development expenditure is 14.8 percent. As far as economic classification is concerned for some categories, like pay and allowances (21.0 percent) and interest payments (18.8 percent) spending rate is higher than overall utilization rate.

## 2.0 DEVELOPMENT EXPENDITURE

### 2.1 ALLOCATION & UTILIZATION PATTERN OF DEVELOPMENT EXPENDITURE

Total allocations against different ministries/divisions for development spending are grouped under 13 broad sectors. Allocation and utilization pattern of **development expenditure**<sup>3</sup> is shown in **Table 3**.

- Up to September 2016, actual expenditure is 6.7 percent of the development budget. The actual outturn for the same period of the previous fiscal year was about 8.1 percent of the revised budget;
- During this period, Recreation, Culture and Religious Affairs sector made the highest utilization of allocated resources (12.3 percent).
- Among the sectors with large allocation, Transport & Communication, Fuel & Energy and Agriculture sectors showed significant performance.



Development expenditure is still under reported in the budgeting information system and it seems there is some time lag between actual expenditure and inputting the same in the system.

## 2.3 BROAD SECTOR WISE UTILIZATION PATTERN

Total development expenditure is further classified under 5 broad categories. Status of actual expenditure under these 5 categories till September, 2016 is presented in Figure 5.

- From the graph it appears that up to September, 2016 the maximum share of spending went to physical infrastructure (59.4 percent) followed by social infrastructure (25.8 percent)



- Total revenue collection in FY16 was 9.9 percent of GDP (base 2005-06) and 96.68 percent of the revised budget target
- In FY17, total revenue is expected to be scaled up to 12.4 percent of GDP (base 2005-06). This figure is about 36.8 percent higher than the revised budget estimate of FY16 and about 41.5 percent higher than the actual collection in the FY16
- Up to September, 2016 total revenue collection for FY17 increased by 13.95 percent compared to the corresponding period of the previous fiscal year (FY16) and achievement as to annual target is 18.0 percent.


- Major share of the government revenue comes from NBR sources (80.85 percent up to September);
- Growth rates of NBR & Non-NBR tax are 17.9 and -5.8 percent respectively. On the other hand, growth in non-tax revenue collection is 0.8 percent compared to the corresponding period of the previous fiscal year (FY16);
- For tax and non-tax revenue, achievements as to annual target were 17.4 and 21.8 percent respectively.

- In FY16 actual tax revenue collection was 8.76 percent of GDP
- Tax **revenue** collection target for FY17 is 10.73 percent of GDP. This is 36.8 percent higher than the revised budget of FY16 and 41.5 percent higher than the actual collection of the FY16
- In FY17 up to September 2016, major portion of the NBR tax comes from indirect taxes. Out of total NBR tax 37.75 percent was collected from VAT, 30.34 percent from income tax, 18.58 percent from supplementary duty, and 12.20 percent from import duty.

- For FY17, actual overall balance up to September, 2016 (excluding grants) as percentage of GDP was 0.04 percent.


