	In order to build Anti-Corruption movement, corruption prevention activities are strengthened through the creation of awareness among the people of the country with the formation of 13-member District/Metropolitan Corruption Prevention Committees and 9-member Upazilla Corruption Prevention Committees. In the pursuit of a society free from the corruption, activities related to corruption prevention are of great importance. Therefore, this has been identified as the second priority area by the Commission.	
3.	Facilitating social movement	
	A social movement against corruption would contribute to the effort to prevent and control corruption. 6.0 Recent Achievements, Activities, Output Indicators and Targets and Expenditure Estimates of the Departments/Agencies

6.1 Anti-Corruption Commission

6.1.1 Recent Achievements: In the last 3years, as many as 850 cases were filed after investigations of 2,282 complaints out of 43,044. Furthermore, backlogs of under investigation corruption cases were greatly reduced by framing charge sheets after investigations of 1158 corruption cases. Altogether an amount of Tk. 272.77 core has been fined and Tk. 78.51 core has been forfeited by disposing 408 cases of the commission and 87 cases of defunct Anti-Corruption bureau. Over the last three years 4,135 cases out of 4,513 (Criminal Revision/Criminal Appeals/ Criminal Misc/writ) filed in High Court have been disposed in order to prevent corruption. 1 metropolitan, 8 metropolitan regional, 62 districts and 422 Upazilla, 3,221 union committee have been formed and 25,371 Integrity Units have been established in schools'. The Anti-Corruption Commission observes Corruption Prevention Week from 26th March to 1st of April and International Anti-Corruption Day on 9th December every year ensuring peoples participation.
