# 3.0 Information on poverty alleviation and women's development

# 3.1 Impact of Strategic Objectives on Poverty Reduction and Women's Advancement

## 3.1.1 All secretarial and political support to Hon'ble Prime Minister

## 3.1.2 Improving living standards of the marginal and minor ethnic community

**Impact on Poverty Reduction:** Government is implementing the *Ashrayan-2* Project which aims at the rehabilitating of 1,51,957 landless, homeless and marginalized families through land distribution, housing, training, health and family planning services, supply of pure drinking water and electricity, development of internal communication infrastructure, construction of community centers, tree-plantation and facilitating access to credits and income generating activities. In every year, 'Development Assistance Scheme (except Hill tracts) for Special Areas' provides large scale income generating projects, micro credit, training

and educational assistance to the small ethnic community living in plain land. As a result, living standard of 100,000 small ethnics has been developed.

Impact on Women's Advancement: In the Ashrayan project, public property and services are provided in joint names of husband and wife. Half of the beneficiaries of the project are women. Social security and dignity of women is increasing due to allocation of government resources to women and along with their participation in different forum, women are being empowered. Women participation is ensured while undertaking large scale income generating projects for the small ethnic community living in the plain lands. Apart from this, Educational supports are also provided to boys and girls of the same section of people. As a result, rates of women are going up, which, in turn, will contribute to the women advancement.

#### 3.1.3 Creating conducive investment climate

**Impact on Poverty Reduction:** Opportunities for direct employment of a large number of Bangladeshi people have been created in EPZ's industrial establishments. Further, creating employment opportunities by attracting new investment in different EPZ and economic areas will play a role in poverty reduction.

Impact on Women's Advancement: At present, women constitute 64% of the labor forces employed in the EPZs. Women's participation in the labor market and income generating activities of the country is playing a vital role in empowering women and increasing their social security. By implementing the World Bank assisted "Northern Areas Reduction of Poverty Initiatives (NARPI)" project, women of the *Monga* prone areas of the northern districts are being trained and provided with jobs in different Industries. It is also expected that by establishing Economic Zones in all prospective areas of the country, significant employment opportunities for women will be created, which will, in turn, improve their living standards and socio-economic conditions.

#### 3.1.4 Increasing private sector participation in infrastructural development

**Impact on Poverty Reduction:** It is expected that PPP initiative would facilitate economic development by building infrastructure, and creating opportunities for employment, which would have a positive impact in terms of enhancing the socio-economic condition of the poor.

**Impact on Women's Advancement:** PPP initiative would facilitate economic development by building infrastructure, and creating significant opportunities for employment, which would also have a positive impact on the socio-economic condition of women.

## 3.1.5 Ensuring transparency and accountability of NGO activities

**Impact on Poverty Reduction**: NGO Affairs Bureau will continue to support and monitor implementation of activities of local and foreign NGOs, which will, in turn, improve the socio-economic condition of the poor.

**Impact on Women's Advancement:** By extending support to the implementation of various projects and Schemes, aimed at ensuring women empowerment, providing health services, access to justice, education and training, nutrition, institutional loans, protection against violence and oppression *etc.*, NGO Affairs Bureau will indirectly contribute to the development of women.

#### 3.1.6 Developing skilled manpower as per National Qualification Framework.

**Impact on Poverty Alleviation**: National Skill Development Authority (NSDA) conducts various skill development activities as per National Skill Framework which will contribute to employment generation and socio-economic development of the poor population.

**Impact on Women's Development**: National Skill Development Authority (NSDA) implements various programs for women's skill development, which will impact on women's development.

# 6.0 Recent Achievements, Activities, Outputs Indicators, Targets and Expenditure Estimates of the Departments/Agencies

#### 6.1 Prime Minister's Office

**Recent Achievements**: Barracks are being constructed on government private land and single houses are being constructed with 02 percent private land through the shelter project for the landless, homeless, uprooted and helpless families of the country. Hon'ble Prime Minister Sheikh Hasina started the Asharyan-2 project in 2010. So far, 62,135 families have built barracks under the Asharyan-2 project, 2,22,789 families have built semi-pacha single houses by providing 2nd century Khas land settlement in Mujib Barsha, 1,53,853 families have built houses on their own land, small people of three hill districts. - Group 600 families, 1100 families affected by Amphan and river floods and 640 climate refugees in the multistoried building of Khurooshkul Special Shelter Project, a total of 4,40,193 families have been rehabilitated. "Not a single person of Bangladesh will remain homeless, with the aim of implementing this directive of the Honorable Prime Minister Sheikh Hasina, the program of rehabilitating landless and homeless families in the country is ongoing through the shelter project in Mujivarsh.] [850 large-scale projects have been undertaken in different upazilas of the country to improve the socio-economic conditions of 80 thousand minority people and 4832 residential houses have been constructed for the homeless belonging to minority groups in the last two financial years.

**Recent Achievements**: Different types of incentives were provided to encourage industrial entrepreneurs to promote the country's industrialization. In the last 3 fiscal-year, Korean EPZA has exported worth about 69,17,82,831.06 million US dollar of manufactured goods. It's increasing every year. Along with the recommendation of E-Visa, 20 work permit of foreigner has been given. Approximately 29,500 people are being employed under Korea EPZ. So far 26,25,000 trees have been planted in the Korean EPZ for green belt.

**6.3.1** Recent Achievements: In the last three years, a total of 96 NGOs have been registered. Out of which 86 are local and 10 foreign NGOs. A total of 5720 projects have been approved and TK. 2,14,559.93 crore was released. The web site has been prepared with new shape and connected to the national information window. Besides, registration of 7,738 local NGOs has been canceled due to irregularities and nonrenewal of registration. For more mobility and transparency in NGO activities, Foreign Grants Regulation Act 2016 has been approved in the Cabinet and made effective on 06/11/2016.

#### 6.4 Bangladesh Investment Development Authority (BIDA)

**Recent Achievements**: In the FY 2015-16 to 2020-21, a total of 9542 industrial projects of local, joint and 100% foreign enterprises have been registered with BIDA with a total investment of 91,94,464.96 million Taka. Employment opportunities for 15,03,952 people have been created in these projects. In order to increase domestic and foreign investment, arrangements have been made for regular publicity on industrial projects registration and investment opportunities through meetings and seminars, roadshow organizing, investment advice, booklets, booklets, annual reports and newsletters. BIDA provides online services in the area of project registration, opening branch, liaison offices, work permit, extension of work permit, issuing different VISA recommendations etc. through BIDA On-line Tracking system (BOST), BIDA Information Management System (BIMS), On-line Receipt, On-line Registration System (ORS). All visa and work permit process including on arrival visa have been made on line. The process of acquiring royalty and various fees repatriation process and foreign loan has been adopted. ## 6.6 Bangladesh Economic Zones Authority (BEZA)

6.6.1 Recent Achievements: With the aim of building 100 economic zones for planned and environmentally friendly industrialization by attracting domestic and foreign investments, 97 economic zones have already been approved, of which 10 economic zones have started production and 27 economic zones are under development. 12 Private Economic Zones have already been licensed from Beza where \$4 billion has been invested. To date, the amount of proposed investment in economic zones has exceeded USD 26 billion. 38 companies have started their production in different economic zones and 70 companies are in the process of starting production. These establishments have provided employment to 50,000 people so far. Besides, 125 types of services of 27 categories are currently being provided to investors from Beja One Stop Service Center, out of which 48 services are being provided online.

#### 6.7 Public Private Partnership Authority (PPP)

6.7.1 Recent Activities: A total of 79 projects from various Ministries/Departments/Organizations have been included in the PPP pipeline, with a financial value of around USD 33.5 billion. Out of these 1project is operational and 8 are under construction. 3 projects are in contract signing stage and 16 are in tender process and 25 are in detailed survey stage. Moreover, 13 projects are in the process of recruiting transaction advisors. Already, 5 billion dollar project agreements have been signed with private partners to implement these projects. An agreement has been signed with private partners for implementation of 1 project in FY 2019-20. Already PPP Authority's Guideline for Contractual Employment in PPP Authority, 2018. Rules for Public-Private Partnership Technical Assistance Financing, 2018, Rules for viability Gap Financing for Public-Partnership projects, 2018 have been published in gazette form. In FY 2021-22, contract signing of 2 projects including 1 of Roads and Highways Department and 1 of Bangladesh Railways has been completed, with an investment value of around USD 12 billion. As many as 9 projects in various sectors have been identified under JTUZ MoUs with the Governments of Japan, Korea, Singapore and UAE. The exchange value of which is about 12 billion US dollars. Besides, MoUs have been signed with Denmark and Saudi Arabia to increase the activities under the J2G policy. Saudi Arabia, China and Turkey have expressed interest in implementing the JTUG PPP project. Ambassadors of the US, Canada and India have shown keen interest in establishing cooperation with PPP authorities during their recent visits over the past 12 months.

## 6.8 National Skills Development Authority

**Recent Activities**: 14 guidelines, national skill development policy on various issues for the purpose of providing skill training according to the demand of the labor market, coordination between the country's skill training institutions, industrial skills council and other beneficiaries, certification, signing mutual cooperation agreements with domestic and foreign government and private institutions etc. 2021 and National Skill Action Plan (2022-27) formulated. Campaign work under NSDA Strengthening Scheme is ongoing. Online registration of training institutes through National Skills Portal (NSP) has started. So far 329 training

institutes have been registered, 110 institutes are conducting courses and 73 institutes have been accredited as assessment centers. 1930 trainees have been assessed through 111 assessments at these centers. Skill certificates have been issued to 2171 people so far through NSP. Besides, 13 sector-based ISCs or Industrial Skill Councils have been formed and the process of formation of 03 ISCs is under process. 77 Competency Standards (CS), 177 Curriculum Course Accreditation (CAD), 28 Curriculum (CBC) and 16 Competency Based Learning Materials (CBLM) have been prepared in various occupations. 43 permanent employees have joined in 13 categories under the organogram.
