Allocations and Activities

1 The main functions of the Ministry of Food are:

- a. Considering the possible adverse effect of environment and climate change, formulation and implementation of policy strategy in the country's overall food management and strengthening of food security;
- b. Import-export of food grain and procurement storage, distribution and movement of food grain (rice and wheat);
- c. Determining the public procurement and sale price, ensuring price stability and sufficient supply of food grains;
- d. Designing and implementing of various development projects of food sector;
- e. Maintaining sufficient stock of food grains, maintenance and testing the quality of food grains;
- f. Food planning, research and monitoring;
- g. Implementation of all the programs undertaken under the Safe Food Act 2013; and
- h. Contacting and communicating with regional and international agencies related to food management.

- d. Building up a stable food security network and ensuring procurement of least 33.10 Lac M. T of food grain from domestic and external sources;
- e. Distribution of 14.30 lac M.T. of food grain through OMS & food friendly program to stabilize the market price of food grains;
- f. Establishment of premix kernel machine with laboratory and construction of infrastructure to ensure nutrition in food grains;

- h. Supply, Distribution of House Hold Silo to Ultra Poor, Ethnic and Disaster-prone area people for safe food storage;
- i. "Construction of composite rice mill along with drying and storage facilities at different locations across the country" project;
- j. "Repair of dilapidated godowns with ancilliary facilities and New Construction of infrastructure across the country" project;
- k. "Construction of a CSD or modern multistoried warehouse at Rangpur district" project;
- I. Implementation of Country Investment Plan(CIP-2) focused on nutrition sensitive Food Systems;
- m. Conducting survey on effectiveness of socio-economic development of the beneficiaries of food based social safety net program;
- n. Conducting survey to assess the variety of paddy as the original source of rice in the market;
- o. Formulation of the Plan of action of "National Food and Nutrition Security Policy,2020";
- p. Updating of the National Dietary Guideline; and
- q. Construction of Central Storage (CSD) at Mohadebpur Upazila, Naogaon District.
