Allocations and Activities

1 **The main functions of the Anti-Corruption Commission are:**

- a. To inquire into and conduct investigation under section 17 of Anti-Corruption Commission Act, 2004, of the offences set out in the schedule of Anti-Corruption Commission Act, 2004, Anti-Corruption Commission (Amendment) Act, 2013 and Anti-Corruption Commission (Amendment) Act, 2016;
- b. To file and conduct cases under this Act on the basis of inquiry and investigation conducted under clause (a);
- c. To hold inquiry into any allegation of corruption on its own motion, or on an application made by an aggrieved person or any person on his/her behalf;
- d. To perform any duty assigned to the Commission regarding anti-corruption by any law;
- e. To review the measures where are recognized by any law for preventing corruption and submit recommendations to the President for the effective implementation thereof;
- f. To make research scheme for prevention of corruption and submit recommendations to the President for taking action on the basis of such research findings;
- g. To create feeling of honesty and integrity in order to prevent corruption and to take measures to raise public awareness against corruption;
- h. To organise seminars, symposiums, workshops etc. on subjects falling within the jurisdiction of the Commission;
- i. To identify various sources of corruption existing in Bangladesh in the context of socio-economic conditions and submit recommendations to the President for taking necessary steps;
- j. To inquire into, conduct investigation of corruption, file the cases against corruption and to determine the procedure of approval by the Commission in respect of such inquiry, investigation and filing of cases; and
- k. To perform such other functions as may be necessary for prevention of corruption.

3 **In FY 2022-23, the following important activities/project/programmes are scheduled to be implemented;**

- a. Reconstitution of "District corruption Prevention Committee" consisting of 13 members and "Upazila Corruption Prevention Committee" consisting of 9 members in all districts, upazilas and unions respectively to institutionalize social movement against corruption throughout the country;
- b. Taking initiative to establish "Satata-Shangha" as an associate body of the Corruption Prevention Committee to create awareness of integrity among the young generation. Creating public awareness against corruption in educational institutions, like schools, colleges, madrasas, universities, dormitories, training institutions etc with the help of corruption prevention committee by involving the youth also;
- c. Forming Corruption Prevention Committee in metropolitan areas;
- d. Implementation of construction of the office building for 06 Divisional offices;
- e. Implementation of project titled "Strengthening the Capacity of Anti-Corruption Commission"; and
- f. Arranging Public Hearing, etc.
