Allocations and Activities

1 **The main functions of the Prime Minister's Office are:**

- a. Provide secretarial assistance to the Honorable Prime Minister in discharging her duties and responsibilities related to political and parliamentary affairs, and other related functions;
- b. Liaise with international organizations and execute treaties and agreements with different countries and international organisations related to the functions of the Prime Minister's Office;
- c. Ensure security of the Honorable Prime Minister and arrange protocol for different Heads of State and Heads of Government, dignitaries and foreign delegates during their visits in Bangladesh;
- d. Undertake programs for small ethnic community living in the plain land to improve their socio-economic condition;
- e. Matters relating to NGO Affairs Bureau;
- f. Coordinate matters relating to the Bangladesh Investment Development Authority (BIDA), Private Export Processing Zone Executive Cell of the Board of Governors and Bangladesh Export Processing Zones Authority.
- g. Deal with administrative matters relating to the National Security Intelligence (NSI) and co-ordinate with all Intelligence Agencies; and
- h. Performing functions related to public-private partnership authority and national skills development.

3 **In FY 2023-24, the following important activities/programmes/projects are scheduled to be implemented:**

- a. Formulation of PPP laws, rules and regulations for undertaking development activities on public-private partnership;
- b. Establishment of economic zones in various areas in Bangladesh;
- c. Implementation of ongoing "Development Grant for Special Area (except Chittagong Hill Tracts)" programme to support the ethnic minority of plain land to improve their livelihood;
- d. Construction of 1 lakh houses on the mark of Mujib Centenary for landless, homeless, uprooted poor families through Ashrayan-2 project;
- e. Facilitate export led growth, employment opportunities, infrastructure development in order to acquisition advanced technology by establishes BEPZA Economic Zone-Mirsarai;
- f. Construction of buildings for rehabilitation of 4409 families in Sadar Upazila of Cox's Bazar District through Khurushkul Special Shelter Project;
- g. Implementation of the Prime Minister's Fellowship as part of various initiatives aimed at increasing the government's ability to achieve sustainable development goals; and
- h. Creation of investor database through Investor Relationship Management System Software (IRMS), provision of information based on investor queries, digitization of manual records of investors, e-monitoring of BIDA-registered projects and preparation of other surveys and dynamic reports.
