Allocations and Activities

1 The main function of the Bangladesh Public Service Commission are:

- Conduction Departmental Examinations for BCS cadre officials and some other non-cadre officials in order to confirm them to their posts;
- d. Conducting Senior Scale promotion examinations for BCS cadre officials; and
- e. Recommendations for disciplinary actions.
