Allocations and Activities

- 1 **The main functions of the Legislative and Parliamentary Affairs Division are:**
- a. Advise all Ministries, Divisions and offices on all legal and Constitutional questions arising out of any legislative proposal and on the interpretation of the Constitution and any law including international law related to such proposal;
 - b. Drafting, scrutinising and providing opinion on all kinds of Bills, Ordinances, Statutory Orders, Rules, Regulations, By- Laws and Notifications;
 - c. Interpretation and recommendation of international treaties, conventions and international legal affairs and matters relating to international arbitration arising out of international treaties, contracts, etc;
 - d. Translation of laws and other Statutory Rules and Orders;
 - e. Administration of copyright of all laws of the Government;
 - f. Publication of Acts, Ordinances and other Statutory Orders, Rules and Regulations and publication of other statutory documents and codification, consolidation, adoption and technical amendment of laws and publication of authorized translation of law;
 - g. Matters relating to Human Rights and the Human Rights Commission, office of Ombudsman, Law Commission and Commission on legal matters and all legislative matters relating to Election Commission; and
 - h. Assistance and Coordination of matters relating to law reforms.
