

Government Order

The undersigned is directed to convey the Government's approval of **Dr. Md.  - f. He will leave Dhaka for Thailand, Bangkok on 19 February, 2018 or nearer suitable date and return to Dhaka on 23 February, 2018 or nearer suitable date.


