Independent Auditors' Report
To the Board of Directors of BCIC

Report on the Audit of the Financial Statements

Qualified Opinion

We have audited the financial statements of **Bangladesh Chemical Industries Corporation (BCIC)**, which comprise the statement of financial position as at 30 June 2020, and the statement of profit or loss and other comprehensive income and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the company as at 30 June 2020, and its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs), the Companies Act 1994 and other applicable laws and regulations.

Basis for Qualified Opinion

- i. As shown in Note No. 7.00 of the notes to the financial statements, an amount of Tk. 7,402,042 is shown under the head "Taken over Loss of Distribution Division" as Non-Current assets which has been carried forward since long without any addition or adjustment. No supporting evidence in support of the said transaction could be furnished to us for our verification.
- ii. An amount of Tk. 90,573,333,713 has been shown under the head "Loan to projects / Enterprises" in the Note No. 9.00 of the notes to the financial statements as Non-current assets. The balance represents outstanding loan that was provided to the sister concerns in the form of loan. Most of these loans have been carried forward since long time without any recovery or adjustments. In addition, Tk. 5,733,946 was provided to Takerghat Lime Stone Mining Project & Waving Bangladesh Ltd. without claiming any interest. Details have been given in the Management Report.
- iii. An amount of Tk. 43,912,414,026 has been shown under the head Investments in Projects/Enterprises as disclosed in the Note No. 10.00 of the notes to the financial statements. These balances represent investment in the sister concerns in the form of equity & shares. Most of these Investments have been carried forward since long time without any recovery or adjustments. In addition, we observed several differences in the amount recorded in the BCIC Accounts with Audit Report/Books of Accounts of the sister concern Projects/ Enterprises. We have also sent Confirmation Letters to those sister concerns but we are yet to receive confirmation from most of the Projects/ Enterprises. Details have been given in the Management Report.
- iv. An amount of Tk. 7,943,000 has been shown as Investment in ICB Islami Bank Ltd. under the head BCIC Share in Note No. 10.02 of the financial statements. The amount has been rearranged from FDR (Head office) in Note No. 17.01 during the year. In this regard, the management has furnished us a letter dated 01.12.2020 submitted by BCIC to the Bangladesh Bank for recovery of Tk. 7,989,348.39 from ICB Islami Bank Ltd. However, no reply letter or evidence of follow-up action for recovery of the total amount could be furnished to us. As such, it causes a lot of doubt regarding recovery the said amount. The management should take follow up action for recovery of the total amount, and in case of no recovery, the amount should be written off.
- v. As disclosed in the Note No. 11 (a) and (b) in the notes to the financial statements, an amount of Tk. 500,000 & 10,453,474,077 has been shown under the head 'Receivable from projects / Enterprise'. Among these figures, some of the individual balances have been carried forward since long without any addition or adjustment. No supporting evidence in support of the said transaction has been produced to us for our verification. Moreover no Receivable Ageing Schedule was produced to us. We have also sent Confirmation Letters to those Projects/ Enterprises, but we are yet to receive confirmation reply from most of the Projects/ Enterprises. Details have been given in the Management Report.



- vi. An amount of Tk. 345,397,731 & 61,437,161 & 1,017,492 & 390,085 has been shown under the head "Receivable from disinvested Enterprises, Advance to Contractor, Deposits, Film & Publication" as Current assets in the Note No. 12 and Sub Note No. 13.01.1, 13.02 & 13.03 of notes to the financial statements has been carried forward since long without making any addition or adjustment. No supporting evidence in support of the said transaction has been produced to us for our verification. As a result, the said amount remained unverified / unconfirmed. It causes a lot of doubt to recovery the said amount, it is more likely that the said amount will not be recovered.
- vii. A Sum of Tk. 73,675 is shown under the head "Cash and Bank Balances" as Current assets in Sub Note No 16.02 of the notes to the financial statements. Under this head an amount of TK. 10,000 has been presented as Imprest MTS for which no supporting evidence such as bank statements or bank certificate were produced before us for our verification.
- viii. A Sum of Tk. 18,288,054,763 is shown under the head "FDR -Head office" as Current assets in the Note No. 17.01 of the notes to the financial statements without complying the accrual basis of accounting. Para 27 of International Accounting Standards 1 requires that an entity Prepare its financial statements, except for cash flow information, using the accrual basis of accounting. The management of BCIC did not calculate any Accrued interest on the investment, mostly on its investment on Fixed Deposit Receipts (FDR).
- ix. Reference to the Note No. 20 of the notes to the financial statements FDR interest income Tk. 1,804,837,252 has been shown under the head "Reserve & Surplus" Sub-head "KAFCO". However, this amount has not been shown in the statement of profit or loss and other comprehensive income as income.
- x. As disclosed in the Note No. 21 of the notes to the financial statements under the head of "Fund for Enterprise", an amount of Tk. 2,934,016,350 & Tk. 37,582,381,397 have been shown under the sub-head "Govt. Share Capital Fund in Companies & Govt. Equity Fund" included in Notes # 21.01 & 21.02 respectively. However, BCIC books of accounts have shown Tk. 3,132,967,600 & Tk. 37,387,733,346 as investment in project and enterprise in the Note # 09 of the notes to the financial statements. As a result liability in Govt. Share Capital Fund by Tk. 198,951,250 has been understated & liability in Govt. Equity Fund by Tk. 194,648,051 has been overstated.
- xi. Reference to the Note No. 22.01 of the notes to the financial statements an amount of Tk. 22,188,239,111 has been shown under the head of "Government ADP Loan" as Non-Current liabilities where most of the loan has been carried forward since long without any payment or adjustment and interest was not charged on some loan portion. Moreover no supporting evidence in respect of the said loan has been provided to us for our details verification. As a result, the said amount remained unverified/ unconfirmed.
- xii. Reference to the Note No. 22.02 of the notes to the financial statements an amount of Tk. 68,265,987,686 has been shown under the head of "Foreign Loan" as Non-Current liabilities. However, no supporting evidence in respect of the said amount has been provided to us for our details verification. As a result, the said amount remained unverified/ unconfirmed.
- xiii. Reference to the Note No. 22.03, 22.04 & 22.05 of the notes to the financial statements an amount of Tk. 178,808,748, Tk. 293,930,000 & Tk. 2,783,464,717 has been shown under the head of "Bank Debenture Loan, Govt. Debenture Loan & Interest Reserve A/c" as Non-Current liabilities which has been carried forward since long without any addition or adjustment. Moreover, no supporting evidence in respect of the said amount has been provided to us for our details verification. As a result, the said amount remained unverified/ unconfirmed.
- xiv. Reference to the Note No. 23 of the notes to the financial statements an amount of Tk. 1,938,751,254 has been shown under the head of "PRICE DEFFERENTAIL A/C-KAFCO" as Non-Current liabilities which has been carried forward since long without any addition or adjustment. Moreover, no supporting evidence in respect of the said amount has been provided to us for our details verification. As a result, the said amount remained unverified/ unconfirmed.



Responsibilities of Management and Those Charged with Governance for the Financial Statements
Management is responsible for the preparation of financial statements that give a true and fair view in accordance with IFRSs, the Companies Act 1994 and other applicable laws and regulations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the organization's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.

If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the organization to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

1.00 CORPORATE STATUS AND ACTIVITIES

Bangladesh Chemical Industries Corporation (BCIC) is a Corporation established under "বাংলাদেশ শিল্প প্রতিষ্ঠান জাতীয়করণ আইন, ১৯৭২" [Former Bangladesh Industrial Enterprises (Nationalization) Order, 1972 (P.O. No. 27 of 1972)]. BCIC has controlled the Enterprises/Projects vested by the Government to it. BCIC came into existence on 1st July 1976 as per P.O. No. 27 of 1976 through merger of Bangladesh Fertilizer, Chemical and Pharmaceutical Corporation (BFCPC); Bangladesh Paper and Board Corporation (BPBC) and Bangladesh Tanneries Corporation (BTC). BCIC is entrusted with the task of supervision, coordination and control of the Enterprises/Projects under its Management and for developing new industries in the chemical and allied sector.

3.00 Basis of preparation and presentations of financial statements

The following underlying assumptions, practices, laws, rules, regulations and accounting pronouncements have been considered in preparing and presenting the financial statements:

- ✓ Going concern;
- ✓ Consistency;
- ✓ Accrual;
- ✓ Historical cost convention;
- ✓ Generally Accepted Accounting Principles (GAAP);
- ✓ বাংলাদেশ শিল্প প্রতিষ্ঠান জাতীয়করণ আইন, ১৯৭২;
- ✓ International Accounting Standards (IASs) and The International Financial Reporting Standards (IFRSs); and
- ✓ Other applicable Acts., Rules and Regulations.

Funds received from the government for ultimate investment to projects are recorded in both liabilities and assets side on contra entry basis.

4.00 ACCOUNTING POLICIES:

4.01 Components of the Financial Statements

- ◆ Statement of Financial Position (Balance Sheet);
- ◆ Statement of Profit or Loss and Other Comprehensive Income (Income & Expenditure Account);
- ◆ Statement of Cash Flow; and
- ◆ Notes to the Financial Statements.

4.02 Recognition of Income & Expenditure

All incomes and all expenditure are recognized and accounted for on accrual basis under conservative concept except interest income on FDR.



4.03 Incorporation of Enterprises/Projects Financial Statements

The Accounts of Enterprises/Projects controlled by BCIC are maintained by them separately which are audited by the independent auditors. The assets and liabilities, income and expenditure of the Enterprises/Projects are not incorporated with the financial statements of BCIC.

4.04 Basis of Valuation

Stores and spares have been valued at average cost and investments in shares have been valued at face value.

4.05 Depreciation

Depreciation on fixed assets have been charged on reducing balance method at rates varying from 2.5% to 25% depending upon the nature of assets. It is the practice of the Corporation not to amortize the cost of leasehold land and in respect of other assets to charge full years depreciation irrespective of date of acquisition.

4.06 Loan and Interest on Foreign and Other Loans

Interest on Loan and Advances where applicable is provided by the Enterprises. BCIC recorded the transactions as contra entry basis.

4.07 Investment in Shares and Equities

Contra entries are maintained in head office books for investment in shares and equities for fund received from Government and others except corporation's own investment.

4.08 Exchange Fluctuation

Loans in foreign currency are converted to Taka at the rates ruling on the last day of financial year. Accordingly, the foreign currency loans are enhanced with corresponding increase in loans to Enterprises/Projects.

4.09 Pension/Gratuity

The corporation has been maintaining pension scheme for its permanent employees under "বায়লান্স কেমিকাল ইন্ডাস্ট্রিজ কর্পোরেশন কর্মচারী (অবসরভাত্তা, অবসরজনিত সুবিধাদি ও সাধারণ ভবিষ্য ভর্তুন) প্রবিধানমালা, ১০১৭" [SRO No. ৩০৯ আইন/১০১৭]
