Executive Summary

The September 2017 issue of the report on Fiscal-Macro position contains relevant data and analysis on the movement of major macroeconomic variables in the current month compared to the same period of the previous year. An overview of the report is given below:

Fiscal Sector

Revenue earnings indicated satisfactory growth at the end of FY172. During July-September of FY18, total revenue collection increased by 17.1 percent compared to the same period of the previous fiscal year. On the other hand, total government spending increased by 8.7 percent during the same period.

Monetary Sector

Broad Money growth was 10.4 percent at the end of September 2017 compared with the same period of the previous fiscal year due to 6.61 percent and 11.8 percent growth in Net Foreign Asset (NFA) and Net Domestic Asset (NDA) respectively. Reserve money growth was 13.4 percent at the end of September 2017 over September 2016.

External Sector

During July-September of FY18, export recorded 7.6 percent growth, which was 3.8 percent in the same period of the previous fiscal year. Similarly, import payments increased by 28.4 percent during the same period. Remittance receipt increased by 4.4 percent during this period. However,, foreign exchange reserve stood at US\$ 32.82 billion at the end of September 2017, which is equivalent to import payments of 7.85 months.

Real Sector

Official statistics from Bangladesh Bureau of Statistics (BBS) reported a robust 7.28 percent real GDP growth in FY17 compared to 7.11 percent growth in the previous fiscal year. At the same time, per capita GNI reached to US\$ 1610 at the end of FY17. The average rate of inflation (12-month moving average) in September 2017 stood at 5.55 percent. On point-to-point basis, it was 6.12 percent in September 2017, of which, food and non-food inflation were 7.87 percent and 3.44 percent respectively. The Quantum Index of medium and large scale manufacturing industries, which is an indicator for industrial advancement of the country, increased by 10.7 percent from the same month of the previous year.

1. FISCAL SECTOR

1.1 Revenue Earnings

Total revenue earning increased by 17.13 percent during July-September of FY18 compared to the same period of FY17. Growth rates of Tax and Non-tax revenue during this period were 21.12 percent and -3.51 percent respectively.



1.2 Grants

Actual grant receipts fell by 52.9 percent in FY17 compared to FY16. During July-September of FY18, grant receipt decreased by 94.1 percent to TK. 4 Crore against TK. 68 Crore over the corresponding period of the last fiscal (table 1.2).


1.3 Government Expenditure


According to iBAS database, total government expenditure increased by 8.7 percent during July-September of FY18 compared to the same period of the previous fiscal (Table-1.3). Similarly, development (ADP) expenditure increased by 39.2 percent within the same period. It may be noted here that, according to the report of Implementation, Monitoring and Evaluation Division (IMED) of Ministry of Planning, ADP expenditure (without self-financing) stood at BDT 15,876 Crore at the end of July-September of FY18, recording 1.36 percent increase over the same period of the last fiscal year.

1.4 Composition of Revenue Expenditure

As of July-September of FY18, spending on Interest payment was the highest (25.4%) followed by spending on education (21.9 %) (Chart1.3).




Chart 1.3: Sector wise share (%) of Non-Development expenditure (FY 18)

1.5 Composition of ADP Expenditure

Sector wise analysis of development expenditure shows that, up to the month of September FY18, highest share of spending went to Physical Infrastructure (63.58%) followed by Social Infrastructure (25.81%).

1.6 Budget Deficit

Overall budget deficit including grants at the end of FY17 stood at 4.95 percent of GDP (Base year 2005-06), which was 3.55 percent in FY16. Overall budget balance including grants during July-September of FY18 records a deficit of BDT 4,436 crore against a deficit of BDT 752 crore for the same period of previous fiscal year.

1.7 Deficit Financing

Domestic borrowing from the banking system decreased to BDT 8,514 Crore in FY17 from BDT 10,613 crore in FY16. On the other hand, borrowing from the non-bank sources increased to BDT 61,322 crore from 40,181 crore during the same period. Net borrowing from the external sources increased to BDT 13,471 crore in FY 17 from BDT 9,020 crore in FY16.

1.8 Sale and repayment of National Savings Certificates (NSC)

The sale of NSC during July-September of FY18 stood at Tk. 19,584.9 crore, which was 17.6 percent higher than that of the same period of the previous year. As a result, net borrowing through NSC stood at Tk.12,694.3 crore at the end of July-September of FY18 (Table 1.6).




Chart 1.5: Outstanding borrowing of government through NSC

2. MONETARY SECTOR

2.1 Monetary and credit development

Broad money (M2) increased by 10.43 percent at the end of September2017 from September2016. Among the sources of broad money, Net Foreign Assets (NFA) rose by 6.61 percent whereas Net Domestic Assets (NDA) increased by 11.81 percent. Domestic credit recorded an increase of 12.80 percent because of 17.80 percent growth in credit to private sector despite -16.91 percent negative growth in credit to public sector.

2.2 Reserve money Developments

Reserve money recorded an increase of 13.41 percent at the end of September 2017 over the same month of the previous year. At the same time, the value of reserve money multiplier increased to 4.78 at the end of September 2017 from 4.52 at the end of June 2017.

3. EXTERNAL SECTOR

3.1 Exports

Export earnings grew by 1.72 percent and stood at US\$ 34,846.84 million during FY17 compared to 9.77 percent growth in the previous fiscal year. During July-September of FY18, export recorded 7.61 percent growth, which was 3.75 percent in the same period of the previous fiscal year.




Chart 3.1: Monthly Trend of Export


3.2 Imports (c & f)


Import payments increased by 9 percent and stood at 47 billion during FY17 compared to 6 percent growth in FY16. Up to September of FY18, import payments increased by a whopping 28.39 percent compared to 8.44 percent growth in the previous fiscal year. Import Letter of Credit (LC) opening and settlement increased by 36.49 percent and 1.87 percent respectively in the same period (Table 3.2).

3.3 Remittance

Remittance inflow fell by 14.48 percent during the FY17 compared to the previous fiscal year's decrease of 2.52 percent. However, remittance inflow recovered to some extent up to September 2017 of the current fiscal year as it registered a moderate 4.38 percent growth compared to -17.49 percent growth of the same period in the previous fiscal year.





3.5 External Reserve


The gross foreign exchange reserve of Bangladesh Bank increased to US\$ 33.41 billion at the end of June 2017 from US\$ 30.2 billion at the end of June 2016. The gross foreign exchange reserve at the end of September 2017 stood at 32.82 billion, which is sufficient to cover import payments of 7.85 months.

3.6 Balance of Payments (BOP)

The country's trade deficit recorded a deficit of US\$ 3.65 billion at the end of September 2017 from a deficit of US\$ 1.56 billion in the corresponding period of the previous fiscal year, which contributed to create a deficit in current account balance by US\$1.79 billion during July-September of FY18 from a surplus of US\$ 0.54 billion in the corresponding period of the previous fiscal year. Overall balance remains US\$ 0.36 billion deficit despite US\$ 1.58 billion surplus in the financial account at the end of September 2017.

4. REAL SECTOR

4.1 Real Sector Indicators

Official statistics from Bangladesh Bureau of Statistics (BBS) reported 7.28 percent real GDP growth in FY17, supported by robust domestic demand, particularly government consumption and investment. On the supply side, growth was driven mainly by industry (10.22 percent) and services (6.69 percent) with the sectoral composition of economy's output continuing to shift away from agriculture. At the same time, per capita GNI raised to US\$1610 at the end of FY17 from US\$1465 in FY16.




Chart 4.1: GDP Growth Rate at current and constant prices (Base year 2005-06)


4.2 Industrial Production


The quantum Index of large and medium scale manufacturing Industries increased by 10.7 percent and became 270.65 at the end of September 2017 from 249.86 at the end of September 2016 (table 4.2). This growth rate of large and medium scale manufacturing Industries was 11.2 percent and 13.5 percent in FY17 and FY16 respectively.

4.3 Inflation

The average rate (12-month moving average) of inflation has eased down to 5.44 percent in FY17 from 5.92 percent in FY16 (table-4.3). However, general inflation edged up to 5.55 percent (twelve-month average basis) in September 2017, of which food and non-food inflation were 6.72 percent and 3.81 percent respectively. On the other hand, point-to-point inflation stood at 6.12 percent in the same month, of which, food and non-food inflation were 7.87 percent and 3.44 percent respectively (Chart 4.3).




Chart 4.3: Trends of Point to Point Inflation (Base 2005-06=100)
