




#### Up to March, FY 09,

Chart 2: Monthly Trend of ADP and Non-ADP Expenditure (FY 07-FY09)




#### a.3.1 Structure of Revenue Expenditure

 Sector wise revenue expenditure shows that highest expenditure is in Interest payment (20.6%), Education (17.3%), and GPS (14.6%).

• Sector wise ADP expenditure shows that, up to February '09 highest share are in Social Infrastructure (57.9%) and next highest expenditure is in Physical Infrastructure (22.0%).







# c.1.1 Structure of Exports



- Strong growth in export is mainly due to increase in Knitwear (19.08%), Woven Garments (17.13%) and Chemical products (57.28%).
- Exports of engineering products, Leather, Raw Jute & Jute goods and Frozen food declined by 11.75 percent, 36.13 percent, 18.55 percent and 17.87percent respectively.





# C.2.1 Structure of Imports (Based on LCs settled)




- Up to April, FY'09 import of consumer goods recorded a decrease of 22.21 percent.




- In FY 08 remittances inflow records a robust growth of 32.39 percent.





- Compare to FY 07, in FY 08 trade gap widens significantly due to the larger increase in import.




- Real GDP growth in FY 09 provisionally estimated to be 5.88 percent of which


