# Chapter-29 Ministry of Housing and Public Works

#### 1.0 Introduction

- 1.1 The government is committed to ensure basic needs of the people by achieving high economic growth by 2021. To fulfill the commitment, a number of activities have been undertaken in divisional cities, different districts and upazillas including Dhaka city to ensure low cost housing for poor and medium income people. Due to high-density of population, Bangladesh is one of the low land ratio countries, where amount of land for housing has been decreasing each year. Considering the overall situation of Bangladesh, it is more important to integrate financial ability of the people and demand for accommodation with maximum utilization of land, to improve the housing system. The Ministry and its attached departments have been working relentlelessly to ensure housing and accommodation facilities for all.
- 1.2 In order to make the development activities of the present government more dynamic, the Ministry of Housing and Public Works has formulated and implemented development plans ahead of Vision 2021 and 7th Five Year Plan. As part of this, Ministry of Housing and Public Works has been implemented planned housing system by constructing plots and flats for low and middle-income people, improved housing system for government officials, extended beautification of the city and development of lake and construction of overpass / flyover for the disposal of traffic congestion.
- 1.3 This ministry plays an important role in providing sustainable, safe, cost-effective housing for low and middle income people, planned urbanization and construction of infrastructures with modern facilities through well-planned and research activities. To meet the pledge "Housing for All", a total of 72 development projects are under implementation for the improvement of plots and construction of flats especially for the lower and middle income people at various metropolitan cities, districts and upazillas including Dhaka under different organizations and departments of this ministry, which will benefit both men and women. Through implementation of different projects, employment opportunities of women have been created, which has been playing key role for their socio-economic development. Apart from this, there are provisions of day care Centre in all the under construction buildings built by various agencies under the ministry.

#### 2.0 Major Functions of the Ministry

- Proper planning and activities to solve the accommodation problem of the country;
- Preparation of architectural and structural design of public buildings and other infrastructure, their construction and maintenance;
- Preparation/amendment of policies, laws, codes of planned housing sector;
- Undertaking measures to ensure planned urbanization, proper use of land and other matters related to development;
- Undertaking activities to solve the accommodation problem of government officers and staff;
- Conducting research and technological innovation on urban development, housing, construction of buildings, construction materials and techniques;
- Management of land and abandoned property under this ministry; and
- Creation of opportunities for involvement of the private sector in solving urbanization and housing problems.

## 3.0 Strategic objectives of the Ministry and their Relevance with Women's Advancement and Rights

- 3.1 **Planned urbanization:** Women are directly affected due to misuse of lands and environment pollution. Proper use of land and environment protection is being ensured through planned urbanization, which has been playing a key role in women's advancement.
- 3.2 Ensure affordable housing for different income groups: Safe accommodation is being arranged by constructing dormitories for the working women under this activity. Consequently, their safety and opportunity for participation in job being encouraged-which has been contributing to women's advancement and empowerment.
- Innovation of technology in planned housing and house construction techniques:

  Training is being provided to women on innovative technology and they are getting involved in marketing these products as small entrepreneurs. Women can directly participate in the activities which has been contributing to the development and empowerment of women.
- 3.4 Ensure cost effective/appropriate infrastructural facilities for Governmental works: Provision for women in accessing government assets and services helps to ensure women's advancement.

#### 4.0 Roles and Responsibilities of the Ministry for Women's Advancement and Rights

- 4.1 One of the important aims of the National Women Development Policy 2011 is to ensure women-rights through providing proper shelter and housing. The Ministry of Housing and Public Works plays an important role in preserving the rights and empowerment of women and creating decent living environment for women through performing duties vested upon the ministry. The ministry has also taken initiatives to ensure women's social empowerment and security through constructing multistoried residential building for various income groups, especially for homeless women and ultra-poor people. Construction of 244 dormitories at the side of Saltgola-Patenga Road in Chittagong has been completed with accommodation facilities of 1,952 female workers. Proper initiatives have been taken to ensure the construction of women and children-friendly infrastructure in the rural and urban areas, to improve the sanitation system and to employ women in the construction of government infrastructure.
- 4.2 The increased participation of women in government services is considered as a milestone in the development process of Bangladesh. The reconstruction of infrastructure in offices is essential for creating women-friendly work environment. Construction of separate dormitories for women, day-care-centre, prayer room and separate toilets for women is essential to ensure women-friendly working environment. The Ministry has been adopting various projects/programs to develop and reconstruct the infrastructure of the government offices to meet up the demand of women. In addition, this ministry has also taken the initiatives of building and maintaining dormitories, hostels for working women in divisional cities including Dhaka. It is mentionable that a large number of women are working in the construction industry. But various forms of discrimination are practiced in this sector. Laws and regulations are being formulated and existing laws and policies are being reformed including accommodation related rules and regulations to ensure equal right and risk-free working environment for women workers.

- Under the project of Chittagong Development Authority, construction of 244 dormitories has been completed in order to solve the housing problem of 4000 women workers working on the side of Saltgola-Patenga Road in Chittagong.

- ❖ Initiatives should be taken to build dormitories in all the districts of the country for Government and non-Government working women to ensure women's safety and security and to increase their participation in work;
- ❖ It is necessary to extend the training programmes conducted by the House and Building Research Institute under "Let us build our own home" program and expand the program across the country;
- Ministry can undertake activities to provide women equal access with men in the construction industry;
- ❖ Taking steps to encourage and ensure women's participation as construction worker in different infrastructure projects; and
- Reserving housing facility for the poor, destitute and working women in the planning of housing and urbanization.
