Allocations and Activities

1 The main functions of the Law and Justice Division are:

- a. Advise Ministries and Divisions on legal and constitutional matters according to their requirements;
- b. Render legal support to the poor litigants seeking justice;
- c. Formulation of rules and regulations regarding appointments and terms and conditions of the service of Honorable Chief Justice and other Judges, and of any other matters relating to the Supreme Court;
- d. All matters relating to the Bangladesh Judicial Service Commission;
- e. Determine and collect fees required for courts and tribunals, judicial stamps, court fees and other stamp fees;
- f. Appoint Attorney General, Additional Attorney Generals, Deputy Attorney Generals, Assistant Attorney Generals and other public prosecutors, and formulate rules regarding terms and conditions of their services;
- g. Functions relating to posting and transfer of the members of Bangladesh Judicial Service and other administrative matters; and
- h. Implementation of rules and policies on land registration and marriage registration.
