Allocations and Activities

1 Main functions of the Ministry of Disaster Management and Relief:

- a. Formulation, review and execution of legislation, policies, plans, procedures, orders and guidelines relating to disaster risk reduction, emergency response and disaster management;
- b. Implementation of plan and policies relating to distribution of emergency humanitarian assistance and preparing and maintaining database on recipient of social safety net programmes;
- c. Administering disaster risk reduction programmes, planning, research and monitoring as well as co-ordination and evaluation with development partners:
- d. Approval, administration and monitoring of safety net programmes such as Test Relief (TR), Food for Works (FFW), Vulnerable Group Feeding (VGF) and other humanitarian assistances;
- e. Employment generation for ultra-poor to reduce risk of lean periods of the year;
- f. Co-ordinating the utilization and distribution of food and other emergency humanitarian assistance received from international agencies;
- g. Implementation of the refugee related activities and co-ordinating with national and International organizations; and
- h. Construction and maintenance of small bridges/culverts and multipurpose cyclone/flood shelters and Mujib Killa to reduce disaster risk.

3 In FY 2018-19, the following important activities projects/programmes scheduled to be implemented :

- a. Formulation of rules on disaster management funds including others; and a policy relating to national disaster management;
- b. Employment generation for ultra-poor and unemployed at disaster prone areas;
- Continuation of disaster Risk Reduction Scheme and taking measures instantly and when required to distribute 1.25 lakh MT of food grain under GR Programme and humanitarian assistance in emergency;
- d. Implementing small infrastructure projects in the rural areas under the Rural Infrastructure Renovation Program at the cost of 1620 core taka and Rural Infrastructure Maintenance Program at the cost of 1415 Core Taka;
- e. Construction of multipurpose flood shelter and cyclone shelter in flood prone, river erosion and coastal-belt areas and repair of old flood shelters respectively;
- f. Construction of Mujib killah in different areas of the country including coastal areas;
- g. Implementation of Construction project of haring bone bond road in rural areas of the country;
- h. Construction of bridges/culverts upto 15 meter long in the rural roads;
- i. Procurement of equipment for search and rescue operations after earth quake and other disasters;
- j. Developing disaster management volunteers with necessary training;
- k. Awareness building on earthquake and all other disasters; and
- I. Construction of disaster resilient houses and infrastructure.
